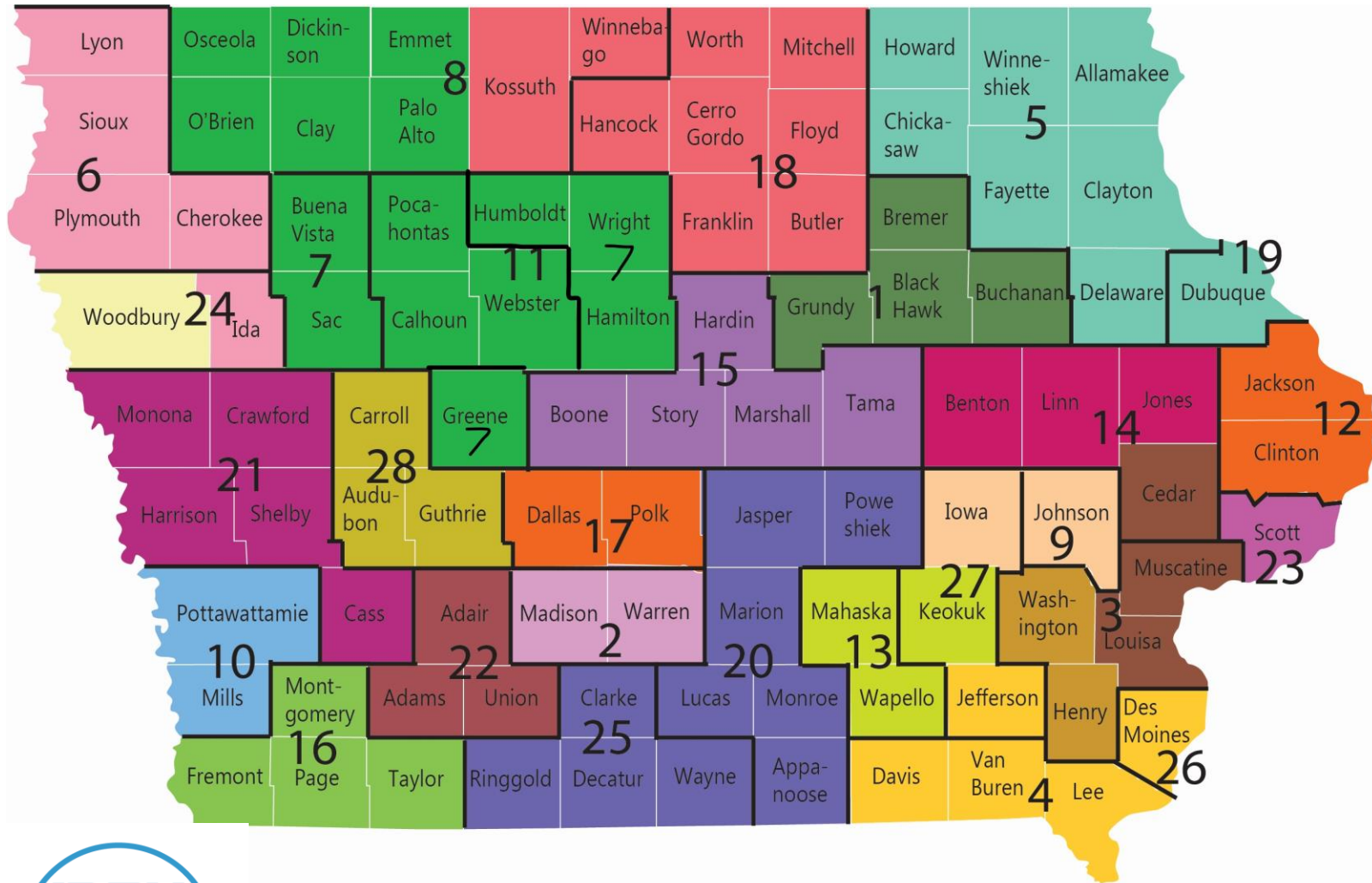


# Healthy Child Care Iowa (HCCI) Map
