

**Immunization Program**  
**Approved Alternate Certificate of Immunization**  
**June 28, 2021**

In accordance with Iowa Administrative Code Section 641.7 *Immunization and Immunization Education: Persons Attending Elementary or Secondary Schools, Licensed Child Care Centers or Institutions of Higher Education*, subsection 7.6(1) Proof of Immunization. "A valid Iowa department of public health certificate of immunization shall be submitted by the applicant or, if the applicant is a minor, by the applicant's parent or guardian to the admitting official of the school or licensed child care center in which the applicant wishes to enroll. To be valid, the certificate shall be the certificate of immunization issued by the department, a computer-generated copy from the immunization registry, or a certificate of immunization which has been approved in writing by the department."
