

## Iowa Department of Public Health Immunization Registry Information System (IRIS) Adding Additional COVID-19 Vaccine Inventory December 28, 2020

The Food and Drug Administration (FDA) has advised it is acceptable to use every full dose of COVID-19 vaccine obtainable from each vial of vaccine. However, since the COVID-19 vaccines do not contain preservatives, it is critical to note any further remaining vaccine that does not constitute a full dose should not be pooled from multiple vials to create a dose. The following scenarios may be utilized to determine if additional vaccine inventory adjustments are required.

## Scenario 1 - Documenting Doses via Data Exchange

It is NOT necessary for healthcare provider organizations conducting electronic data exchange to add additional vaccine doses to inventory. Vaccine doses sent via data exchange will document appropriately to IRIS. Contact the IRIS Help Desk at 800-374-3958 with questions regarding electronic data exchange.

## Scenario 2 - Documenting Doses via Manual Data Entry

IRIS vaccine inventory can be adjusted to add additional COVID-19 vaccine doses beyond the anticipated vaccine doses per vial. The additional vaccine inventory must be added prior to documenting vaccine doses via manual data entry. COVID-19 vaccine doses administered from IRIS inventory will not deduct if the inventory value is zero. It is critical to adjust IRIS inventory to account for these instances. 1. Select the 'manage inventory' link under the Inventory section on the left menu panel.

4. Search for the appropriate vaccine lot number. Inactive lots are displayed in red. After locating the lot number, select the blue trade name link.

- 5. On the Edit Inventory page, navigate to the Modify Quantity On Hand section.

  - c. Select the 'New Shipment' reason from the Reason dropdown menu.
  - d. Change the Lot Active field from No to Yes.
  - e. Select the 'Save' button.
